

## International research in microeconomics

Centre for Economic Analysis – CenEA is an independent research institute aiming to provide highest level analysis of consequences of economic and social policy in Poland. Established by the Stockholm Institute of Transition Economics (SITE), the Institute cooperates with research institutes from the Baltic countries and Eastern Europe within the FREE Network.

CenEA has a strong academic focus and is the Polish partner for the tax-benefit microsimulation model for the European Union (EUROMOD). Until 2017 the Institute was also the coordinator of participation of Poland in the Survey of Health, Ageing and Retirement in Europe (SHARE). CenEA publishes commentaries on tax and benefit policy in Poland and is active in the public debate on social and economic policy issues.

In 2019 CenEA will recruit two graduates for the Research Economist positions to work on a number of applied research projects with an important policy component.

### Basic requirements:

- **master's degree in social sciences (economics, sociology) or natural sciences**

- **documented strong academic background**
- **interest in economics and economic policy**
